TERMS AND CONDITIONS

1. Professional Development Bundles are based on an annual, renewable subscription, invoiced directly to the council.
2. Professional Development Bundle benefits will be made available to council upon payment of the Professional Development Bundle invoice.
3. Once payment has been received, council will have the opportunity to nominate staff members to receive membership, tickets to the LG Awards Dinner (as applicable) and registration for The New Manager Toolkit, Local Government Finance Intensive Course or Local Government Governance Intensive Course (as applicable). It is council's responsibility to ensure all nominated staff members return fully completed membership and event registration forms within the time frames specified on invoice. Where council staff fail to return this information within the timeframe, no refunds will be provided for lost member benefits or course unavailability.
4. Delegates attending the LG Awards Dinner, The New Manager Toolkit, Local Government Finance Intensive Course, Local Government Intensive Governance Course or or LG Industry XChange do not have to be the same staff members nominated for the membership component.
5. Those staff nominated to receive the membership component will be considered individual members under the Local Government Professionals Australia, NSW Membership Policy, receive the associated benefits and will be bound by the Local Government Professionals Australia, NSW Code of Conduct.
6. Should a council wish to include a current financial individual member into their professional development bundle, this can only be done at the individual member's time of renewal.
7. Once nominated staff have been provided membership, councils can only reassign that membership to another staff member should the nominated contact leave council and only within the first six months of initial payment or renewal. No prorating of bundle fees will be considered for lapsed time in reallocating the membership.
8. If council wishes to purchase additional memberships over and above what's included in the Professional Development Bundle – this will be negotiated with the individual council. Multiple bundle packages can be purchased by the one council.
9. Should the staff members nominated to receive membership leave council, they are entitled to apply for Local Government Professionals Australia, NSW individual membership when they commence employment at another council. Should the nominated staff member leave council and not re-enter employment with another council, they will not be entitled to apply for individual membership.
10. Bundle members are able to access all individual member benefits.
